## TIME BANDING FOR BAGGED WASTE, RECYCLING AND CARD BOARD BUNDLES

The new time banding initiative has been in place since 1 April. Improvements can already be seen to the general appearance and cleanliness of the City. There have been a few problematic corners of the Ward which we have reported and which are now being carefully monitored. Concerns have also been raised with us by residents and small businesses who may not be available to put out rubbish at the allocated time. ## NEW NOISE STRATEGY

The City of London is reviewing its Noise Strategy and we will report further once this has been completed. Complaints about noise are investigated by officers in the Pollution Team. Most noise pollution in the City arises from commercial activities. In most cases the Pollution Team deals with noise problems by assessing whether the noise is “unreasonable”, taking into account factors such as loudness, time of day, frequency and duration. Noise deemed unreasonable is then dealt with as a “statutory nuisance” under the Environmental Protection Act 1990. Complainants should be aware that Pollution Team officers usually have to witness the noise before taking formal action. Where noise is thought to be a statutory nuisance the City of London must serve an “abatement notice” on the person or organisation responsible. The scope of the notice will vary with different circumstances and may require an immediate stop to the noise or prohibit its recurrence. In some cases, particularly where works are necessary, a specified time may be given for compliance. Failure to comply with an abatement notice is an offence and the City of London can prosecute.

The Pollution Team can deal with most cases of nuisance noise including noise from construction sites, road works, pubs and clubs, plant and air conditioning, intruder alarms and noise from commercial premises. However it has no powers to deal with railway, road traffic, aircraft / helicopter noise or unruly behaviour in public streets.

## WARD MOTE 9 MARCH 2012

A well attended annual Ward Mote took place on 9 March at the St Bride Foundation Institute. This was an opportunity for voters to meet their Ward Members and raise any questions. Following a report on current issues within the ward, questions were taken. Besides the new scheme for collection of bagged waste, these included:

**Provision of more cycle racks:** We are pleased that additional cycle racks are being installed, as part of a TfL programme. Additional racks have recently been installed at the north end of Fetter Lane. Further cycle docking stations have also been installed in Stonecutter Street.

**Play Area Peter's Hill:** An elector suggested that the play equipment is causing a nuisance to nearby offices. This equipment was installed under an externally funded scheme after extensive consultation, as it was perceived that there were limited opportunities for play in the square mile. City Officers are monitoring the level of use of the equipment to assess whether there is excessive noise or nuisance, and tell us there have been no other complaints. At present it is not proposed to relocate the equipment, although this will be kept under review.
