**LUDGATE CIRCUS – TRAFFIC INCIDENTS**

As previously mentioned, your members have been very concerned and saddened by the two fatal accidents in the past six months at Ludgate Circus. This junction has one of the worst accident records in the City with 34 accidents being recorded over the last three years – half of which involved cyclists. We are pressing for action. At the last Court of Common Council on Thursday 4 December, we asked the City’s Chairman of Planning & Transportation Committee for immediate steps to improve safety at the Ludgate Circus junction while we are waiting for the Cycle Super Highway to come into effect. Transport for London has already put up so called “trixi” mirrors on the traffic light poles around the junction. The City has also been urging them to put up “Think Bike” signs at the junction entrances and more 20mph signage. The City of London police are also stepping up their operations and the City Corporation has signed up to the Safer Lorries Scheme, and are pressing on with its own Road Danger Reduction Plan. In addition, the City has registered its serious concerns about TfL’s proposals for the Cycle Super Highway as they stand today, particularly as regards pedestrian safety and utility, and the relevant City Corporation teams are now working very closely with their counterparts at TfL to find ways of meeting the City’s concerns, which are related to the safety of all road users. Your ward members have requested to receive regular updates on the specific progress of the immediate steps to be taken which we will report back on.

**LUDGATE HILL CROSSING – UPDATE**

The much delayed one year trial of a signalled crossing at Ludgate Hill has finally been given the go ahead and is now due to start early in the new year. As we have previously reported, all of your ward members have been pressing for this for several years to help traffic flow at busy times of day and to reduce air pollution in the ward, when traffic tends to back up due to continuous pedestrian movement across the crossing, so we are very pleased that this is now finally happening.

**LITTER: BIG BELLY BIN RELOCATION**

When bagged rubbish, business or residential, is not collected according to the time banding rules it attracts general litter and it is important to address these hot spots as soon as possible. Recently, we have been working very closely with the City Corporation’s street enforcement officers in order to deal with some specific litter issues in the ward, and one such site, for example, has been around the Sainsbury’s store in Fleet Street. As the Big Belly bin in New Bridge Street was not used to its full capacity, we met and discussed the possibility of moving it to Fleet Street instead, which has now been done on a trial basis. We will continue to monitor the situation with the assistance of our street environment officers.

### NEW STREET SQUARE CONSULTATION

We have reported before on problems caused by heavy vehicles negotiating the narrow streets on the south side of the New Street Square estate. As part of the planning permission granted in April 2004, an undertaking was given to examine traffic flows around the estate after its completion and to examine the possibility of preventing through traffic along Pemberton Row. Following a traffic survey, proposals are now out for consultation. These are aimed at ending the current problems by introducing double yellow lines on the north side of West Harding Street, Pemberton Row and East Harding Street and a 7.5 tonne limit, except for loading vehicles. In addition, the possibility of a no entry sign just north of the entrance to Gough Square is also proposed, to prevent through traffic from west to east.
